# 63 APPLICATION BY AIRBUS UK LIMITED FOR AN INTEGRATED POLLUTION PREVENTION (IPP) PERMIT FOR ITS MANUFACTURING FACILITY AT BROUGHTON

Councillor RA Storrar had brought the above application to the Council's attention at a meeting held on 5 August 2002. The Council subsequently referred the application to the Planning Committee for its consideration.

The Environment Agency had consulted Chester City Council on the application but as yet the Parish Council as a neighbouring parish had not been consulted.

The aircraft factory at Broughton, although situated wholly within Flintshire, was at its closest point just over one kilometre from the boundary with Chester District. Airbus UK Limited manufactured wings for the Airbus range of commercial aircraft and the fuselage and wings for the Hawker private jet at the facility. The Broughton site was presently expanding in preparation for the production of the new A380 Airbus "double decker" aircraft. The expansion was considered a "significant change" under the Pollution Prevention Control Regulations and it was necessary for Airbus to apply to the Environment Agency for a permit to operate the installation. Two other companies, Metal Improvement and Stiel Facilities, were also applying for permits at the same time to operate linked operations at the same installation.

The activities carried out on site were:

Combustion of fuels for heat and electricity
Machining of aluminium
Forming of aluminium using heat and pressure
Chrome anodising of aluminium
Painting, priming and top coating
Assembly of components

Two other companies on site would carry out operations linked to the Airbus process that would be covered by separate applications. These were the Metal Improvement Company – who carried out the processes to improve fatigue resistance of aluminium, and Stiell Facilities who would operate the new Combined Heat and Power Plants to be installed on the site.

The application for the IPP Permit was accompanied by an environmental impact assessment (EIA) which detailed the abatement techniques that the company would use to mitigate the effects of any releases from the processes. The EIA indicated that the current and proposed activities on site were unlikely to have a harmful effect on the environment. To confirm this Airbus UK would carry out additional environmental monitoring and undertake further assessment work.

It was concluded that the environmental impact of the factory would have little effect on Chester District and it was not intended that Chester City Council would make any comment on the application to the Environment Agency.
