Following receipt of a complaint by Mr K Stinson over the way in which a previous planning application in Beeches Lane had been handled the Committee reviewed the procedure it had adopted.

A site visit had been undertaken and the applicant had asked, and had been told, when the Committee would be considering his application. Subsequently, the applicant's wife had attended the Committee as an observer. She had not made any representations but the Committee had taken the opportunity to ask her a couple of questions.
