From the Chairman, Alan Bailey

Welcome to the first newsletter of 2020. In February the Parish Council's budget is submitted to Cheshire West & Chester Council (CWaC) for inclusion in the Council Tax for the 2020/21 period. For three years the Parish Council has collected £56.20 p.a. from each Band D property in the village (the precept). However, in this next financial year we have decided to increase the precept by 3.3% taking it up to £58.05. increasing the amount we collect by approx. £1,900. Please see the end of the newsletter for further details.

<u>Virgin Media</u> We have received enquiries about the number of residents who have signed up for Virgin Media services. As of 1st Jan 2020, one in five households who have the potential to be connected have taken advantage of the packages on offer,

approx. 250 households. Chairman's Awards

Subject to approval at February's meeting, the Council has agreed to open the Chairman's Awards programme for 2020, inviting applications from Saughall-based voluntary and community groups within the Saughall area to apply for funding from the Parish Council. Applications are invited for projects / activities up to the value of £2,000, though much smaller amounts are most welcome. A budget of £4,000 has been set aside for this purpose. Funding is intended to benefit the community so applications that only benefit one individual are not suitable. Eligible organisations / projects include:

- Voluntary or community groups or faith groups
- Local environmental projects

Shotwick Park Estate Project

Many were unable to attend the two public meetings facilitated by the Parish Council in December and have asked for a short description of the project. This is not a Parish Council initiative - a private individual, Mr Lex Greensill, has approached CWaC to purchase 550 acres of land in the Shotwick Park area of the village. Mr Greensill contacted the Parish Council some time ago to introduce us to his project and we are supportive of such a far-reaching and beneficial venture for the village and its residents. Although there are many hurdles, we will back Lex in any way that we can.

The Vision is to create a natural sanctuary for

Shotwick Park to address the growing threat of wildlife decline and climate change. The project will offer a wide range of community benefits including access, education and place of research – a local scheme for a global issue. It centres around four main 'Statements and Aims'

Natural Environment and Wildlife – An opportunity to create a habitat mosaic which will restore a more naturally functioning ecosystem to Shotwick Park. **Develop** existing key habitats; parkland, mixed native woodland, field margins and hedgerows Restore & Improve the ecosystem services provided through features such as ponds, watercourses and low-lying meadows.

Establish grasslands rich in flowers and herbs, providing wildlife corridors and super-highways for pollinating insects.

Community and Social Benefits – Landscape benefits will be significantly enhanced with the visual


Below is a map of how the project may look and includes the following headings:

impacts of wildflower meadows and woodland creation, whilst protecting iconic viewpoints of the Welsh Hills.

Create a community orchard leading to an edible pathway.

Maintain employment opportunities through environmental, educational and agricultural enterprises.

Restore more natural function to our countryside, allowing our flora and fauna to flourish.

Land Management in a Changing Climate –

Creating new woodlands not only absorbs carbon, but also improves biodiversity and will connect fragmented habitats.

Improve soil health by creating a stable structure, building levels of organic matter and reducing both erosion and compaction.

Plant native woodland with the tree mix carefully considered, accounting for both habitat provision and the ability to mitigate climate change.

Research climate mitigation via the delivery, valuation and financing of carbon sequestration.

Access & Education – An opportunity to encourage more members of our community to enjoy the recreational health and wellbeing benefits derived from the natural environment.

Enhance access by maintaining the network of public rights of way and creating an all ability path to benefit all members of the community. Provide for an increase in visitor numbers, by considering the requirements for signage, car parking and accessible toilets. Establish educational opportunities for all members of our community from toddler groups to academic institutions.

The Council is trialling dog walking in the Golden Jubilee Park from 1 January until 30 June 2020 and if successful it may continue indefinitely.

Dogs must be kept on a lead at all times and you must always pick up after them and take it home.

Dogs are allowed to walk around the perimeter path and must not be taken onto the Cricket Pitch, BMX Track or the Younger Children's Play Areas.

Christmas Lights

Many residents have expressed their delight at the expansion of the Christmas lights along Hermitage Rd. We are now asking residents whether they would like to see a further expansion along Church Rd from the junction with Saughall Hey to the Fiddlers Lane junction. Currently the annual rental cost is £4,400. The approximate cost for the extension would be a one-off payment for 12 lamp posts to be fitted

with the necessary switch gear and plugs of £1.000 and the annual rental of the actual Christmas garlands at £1,500, taking the annual rental up to approx. £6,000. If this is shared by every household in Saughall it means the annual cost of all Christmas lights would be approx. £5.00 each. Do you think that this is good value for money? Parish Council Budget 2020/21 At a meeting in January 2020 your Council met to consider its budget for the forthcoming financial year starting in April 2020. Before doing so, we thought that it would be useful to list community spending 2019/20 (over £1,000)

Parish Precept: This is a charge on each household for the running of the Council collected from each household in Saughall & Shotwick Park. Last year we collected £56.20 based on a Band D equivalent property, and this figure had been frozen since 2016. After due consideration the Council decided to increase the precept to **£58.05**, (£1.11 per week) which represents a 3.3% increase. The total budget for 2020/21 will be £95,688.
